- 2. Recognize that computers are for academic purposes and games will not be played unless given permission by a teacher.
- 3. Recognize that software is copyright protected: therefore, do not make unauthorized copies, and or give, lend or sell copies of software without written permission of the copyright owner, or the original software is obtained and is clearly identified as shareware or public domain.
- 4. Recognize that all user's work is valuable. Please protect the privacy of others by obtaining passwords, reading, copying or changing their files without prior permission. Do not attempt to gain unauthorized access to system programs or computer equipment.
- 5. No use of the network shall serve to disrupt the use of others; hardware or software shall not be destroyed, modified, or abused in any way.
